



WHEREAS, the SETTLOR/MANAGING TRUSTEE and the then existing TRUSTEES had executed a Deed of Trust dated 26.11.2004 duly registered before the office of the Sub-Registrar of Bardez, at Mapusa, Goa, under Registration No. 44 at pages 18-32 of Book No. IV, Volume No. 5, dated 02.12.2004; under the name of "Daleep Singh Education Trust" and hereinafter referred to as the Principal Deed of Trust;

AND WHEREAS, the Trustee under serial No.1 of the TRUSTEES mentioned in the Principal Deed of Trust viz. DAVINDER SINGH PANESAR expired on 04.12.2008 and is presently survived by his widow viz MRS. RAVINDER K. PANESAR, who is also the SETTLOR/THE MANAGING TRUSTEE herein;

AND WHEREAS, the Income Tax Department vide letter dated 08.09.2016 has requested to include some vital Amendments, which are now going to be incorporated by way of the present Addendum to the Principal Deed of Trust;

AND WHEREAS, by this present Deed of Addendum to the Deed of Trust of Daleep Singh Education Trust, it is decided that all such vital amendments shall be incorporated in the Principal Deed of Trust, in order to be recognized under and/or avail the benefits under Sec. 80 G of the Income tax Act 1961 and/or any other benefit available, in terms of law in connection to the Income Tax Act 1961 and Rules thereunder including amendments, in pursuance to the application for registration under Sec.12A Act moved by the Trust namely Daleep Singh Education Trust.





NOW THIS DEED OF DEED OF ADDENDUM TO THE DEED OF TRUST OF DALEEP SINGH EDUCATION TRUST dated 26.11.2004, WITNESSES AS UNDER:

1. On page 23, of the Principal Deed of Trust, the following paragraphs are to be inserted after Para. No. 36 of the Principal Deed of Trust by way of the present Addendum. i.e. Para Nos.37,37A,37B,37C,37D and 37E”:

37. AMENDMENT CLAUSE: No amendments to the trust deed shall be made which may prove to be repugnant to the provisions of section 2(15),11,12 and 13 and 80G of the I.T.Act,1961, as amended from time to time. Further, in connection to the aforesaid no amendments shall be carried out without the prior approval of the Commissioner of Income Tax.

37A. BENEFICIARY CLAUSE: The Benefits of the Trust/Society shall be open to all irrespective of caste, creed or religion.

37B. ACCOUNTS CLAUSE: There shall be maintained all accounts of the Trust/Society regularly. The accounts shall be duly audited by a qualified Chartered Accountant. Every year the accounts shall be closed by 31st March.

37C. INVESTMENT CLAUSE: The funds of the Trust/Society shall be invested in the modes specified under the provisions of section 13(1)(d) r.w.s.11(5) of the I.T. Act, 1961, as amended from time to time.

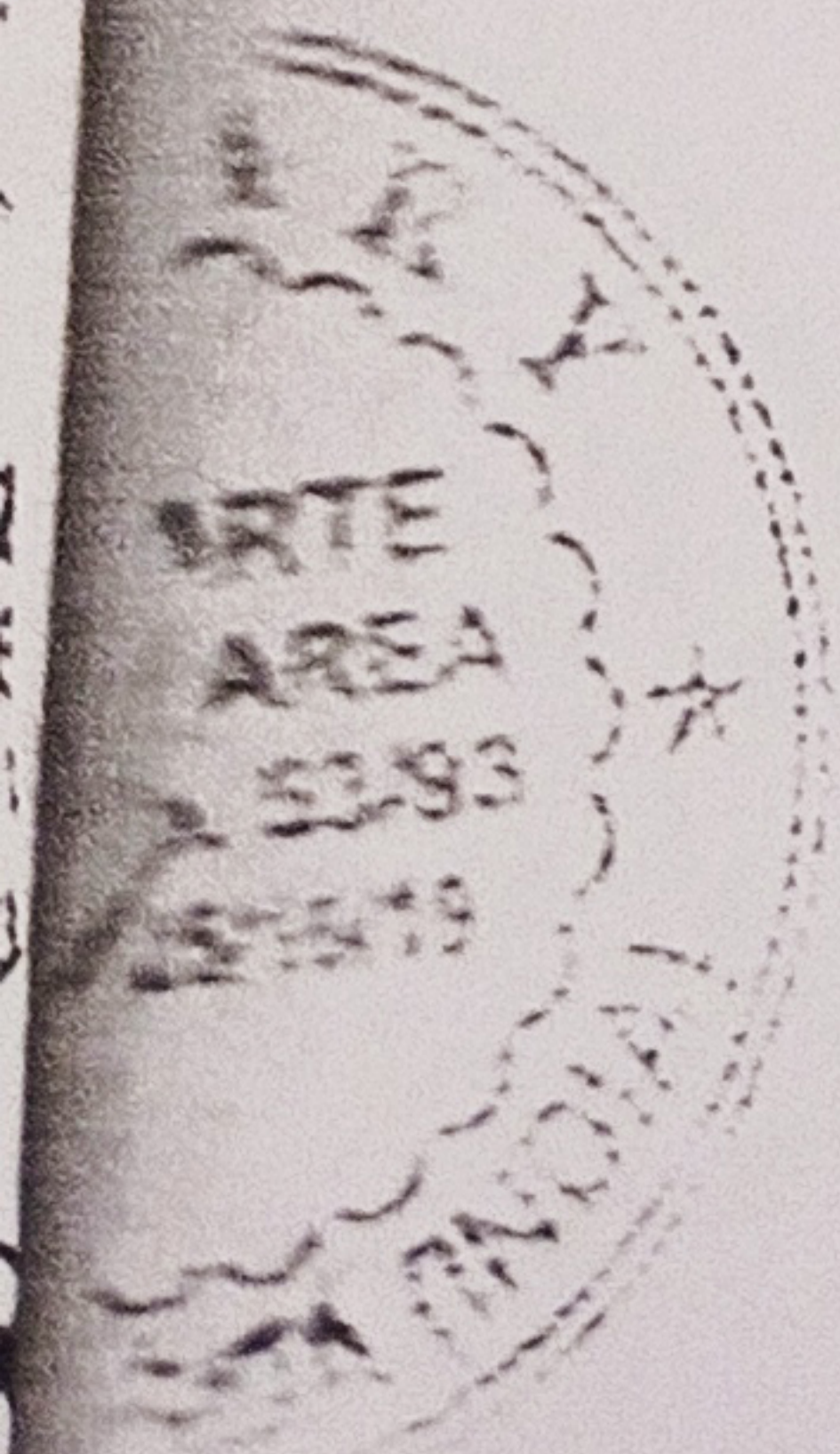




37D. UTILISATION CLAUSE: The funds and the income of the Trust/Society shall be solely utilized for achievement of the objects of the Trust/Society and no payment shall be made to the Trustee/Members by way of profit, interest, dividends etc.

37E. DISSOLUTION CLAUSE: In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/Governing body but the same shall be transferred to another Charitable Trust/Society whose objects are similar in those of this Trusts/Society(s) and which enjoys recognition u/s.80G of the Income Tax Act, 1961, as amended.

2. That save and except for the above, the **Principal Deed of Trust**, shall remain in force and unaltered.
3. The **Principal Deed of Trust**, shall be read along with this present Deed of Addendum to the Deed of Trust of **Daleep Singh Education Trust** dated 26.11.2004, alongwith all resolutions duly adopted, till date, for all legal purposes and effects.

IN WITNESS WHEREOF, THE SETTLOR/MANAGING TRUSTEE of the **ONE PART** and **THE TRUSTEE** of the **SECOND PART** have signed this Deed of Addendum to the Deed of Trust of **Daleep Singh Education Trust** on the day, month and year, first hereinabove mentioned in the presence of two attesting witnesses.

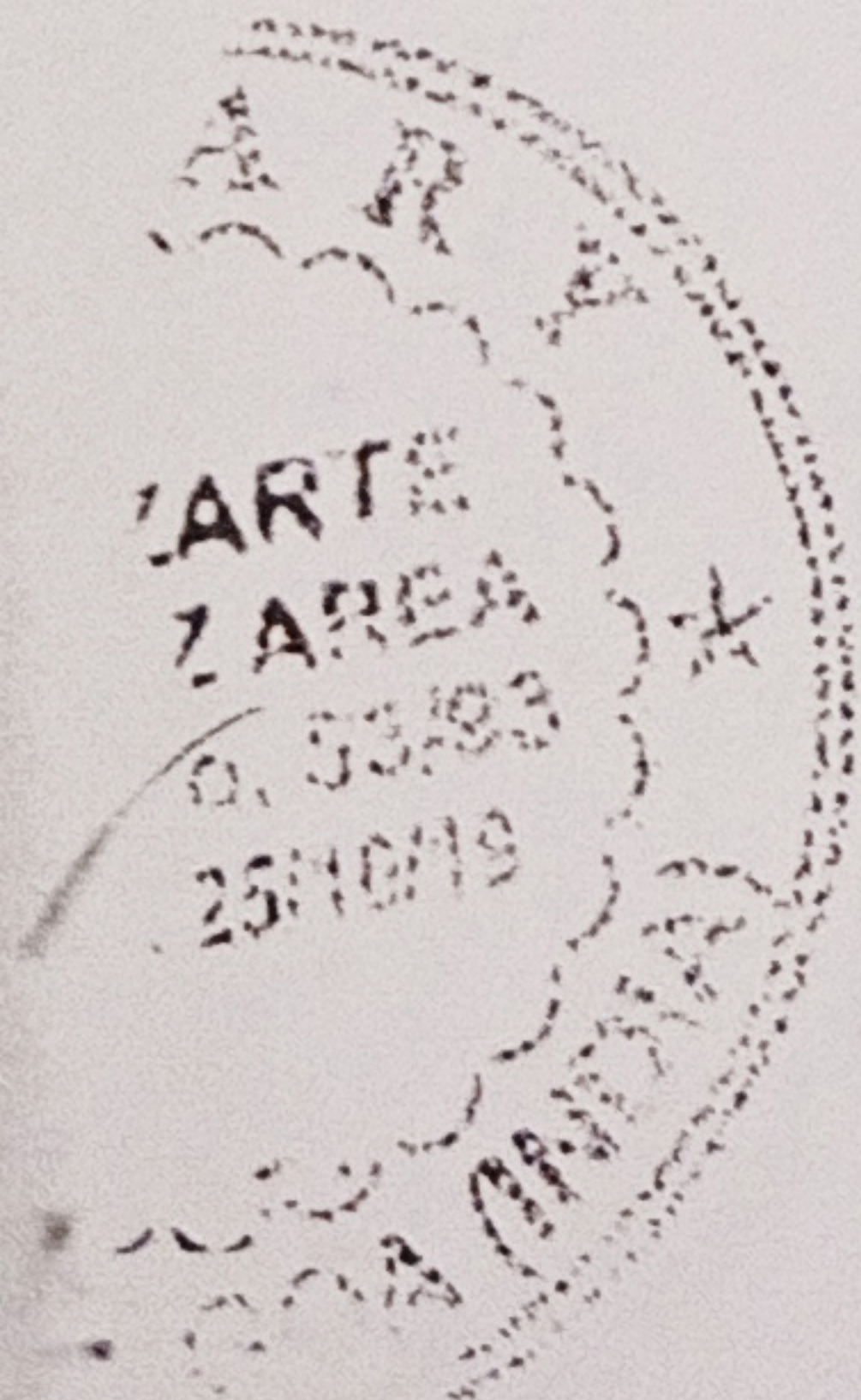

LEFT HAND FINGER IMPRESSIONS

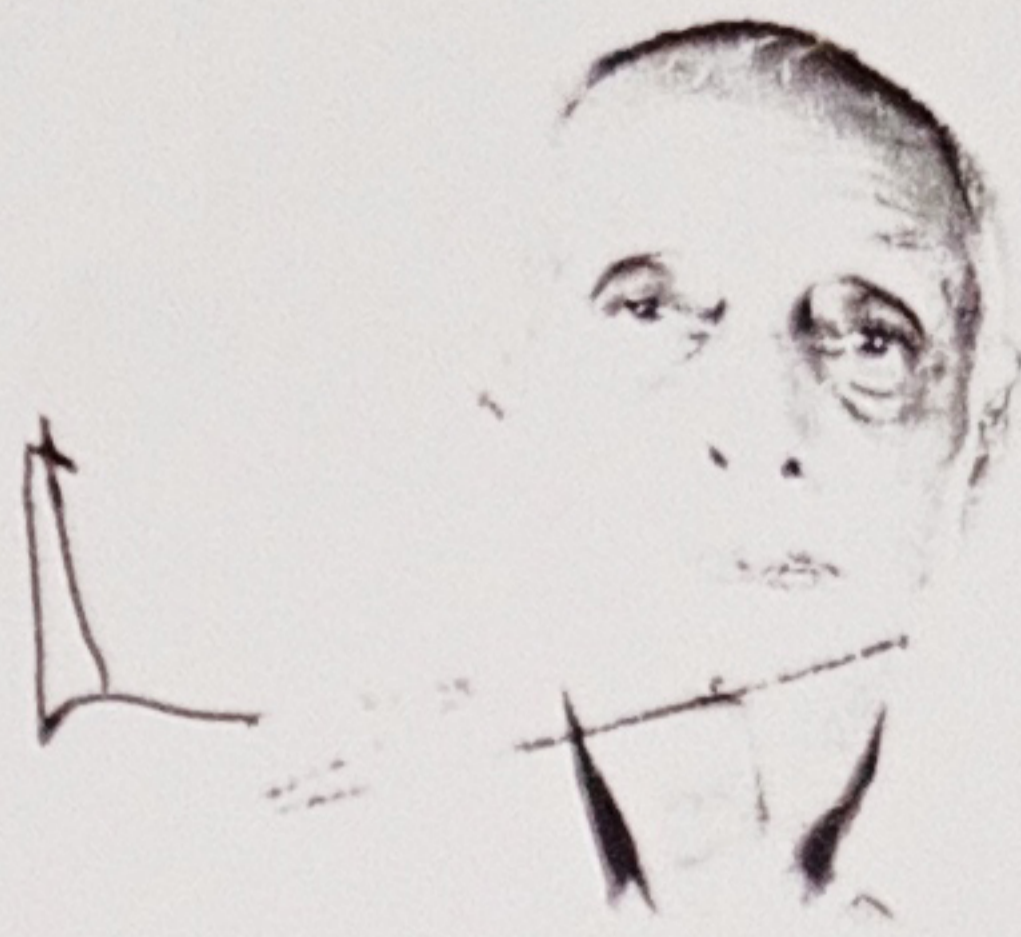


RIGHT HAND FINGER IMPRESSIONS

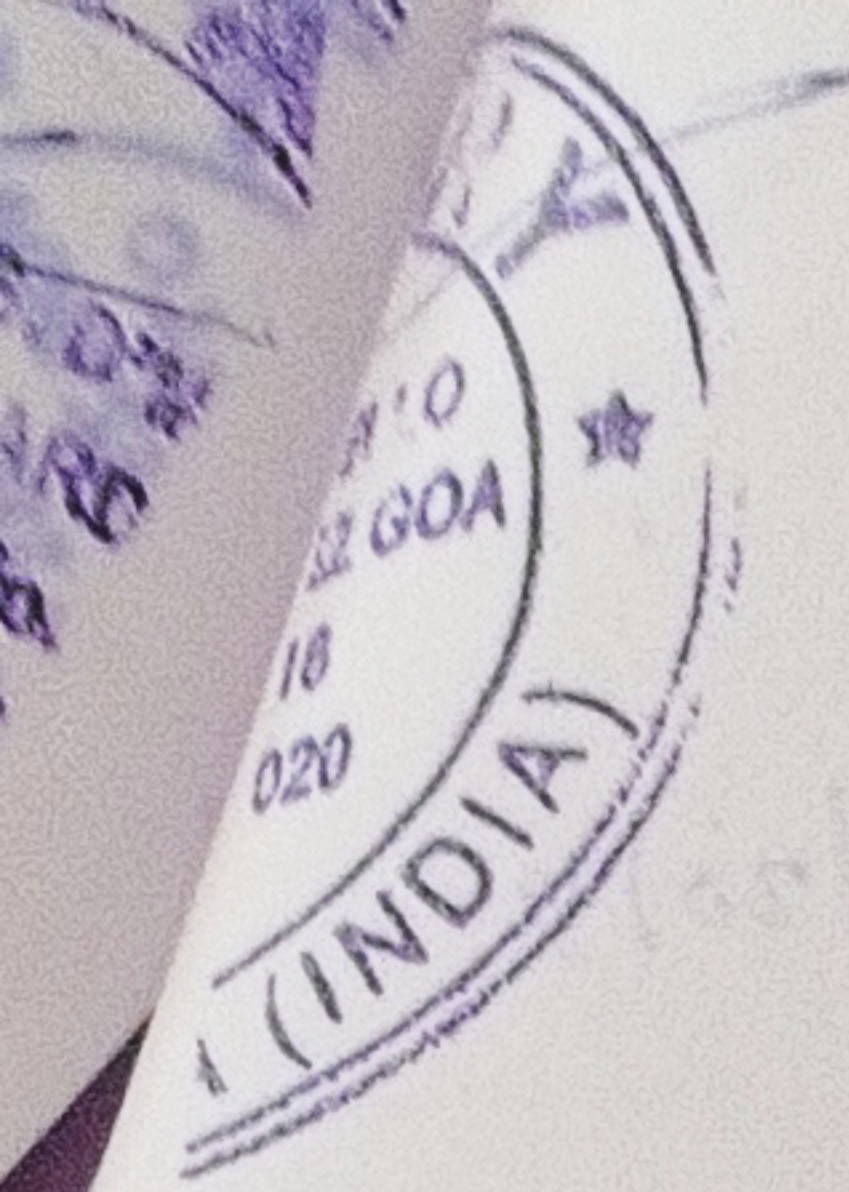


LEFT HAND FINGER IMPRESSIONS

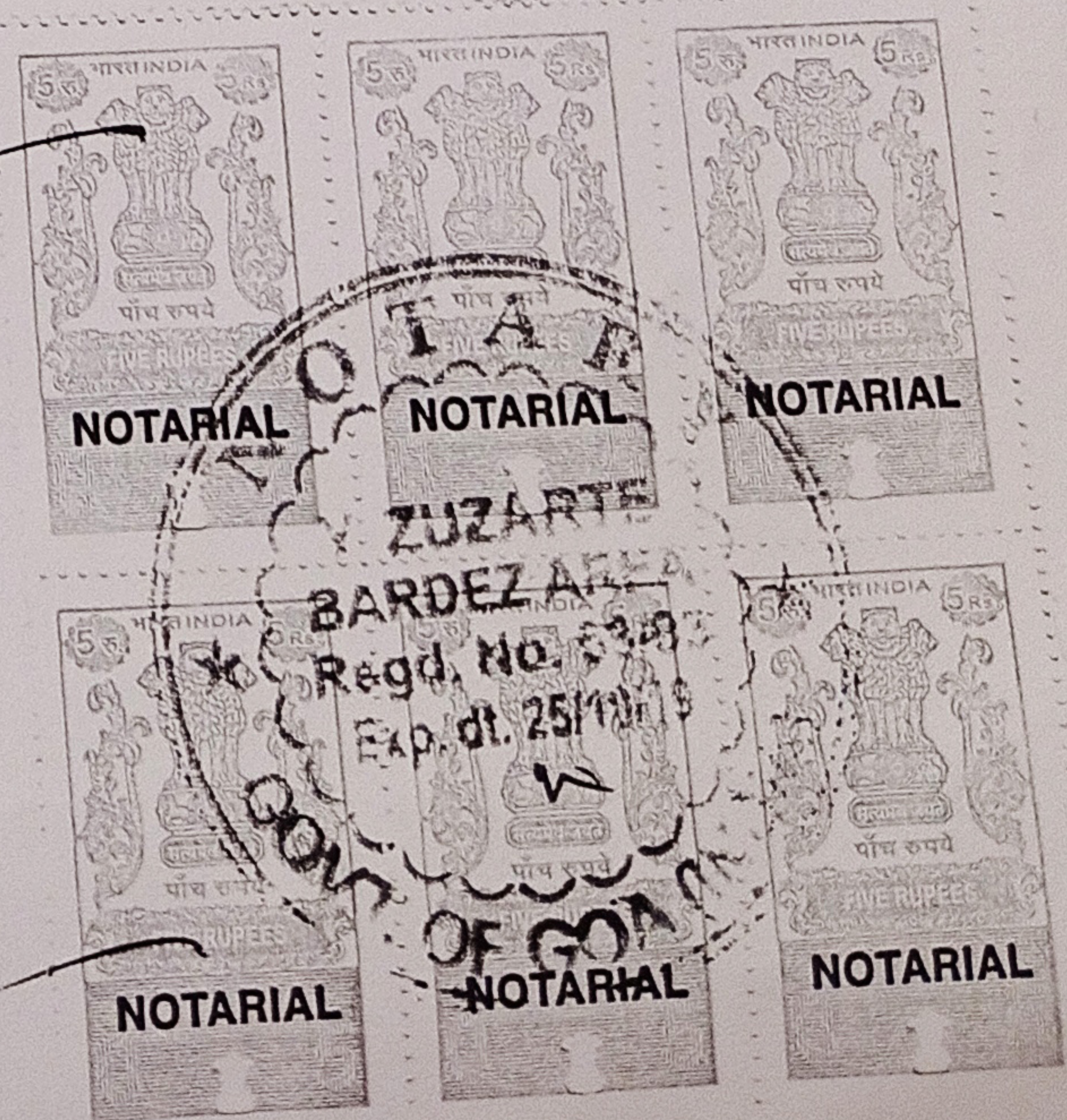
